

Bracks' Poverty Remedy – A vote for Labor is a vote for murder DO NOT VOTE LABOR.

The Defendant (author) is amazed at the circumstances he now finds himself in.

1. Defendant's father dies from stomach cancer – resulting from inflammation – caused by regular doses of mercury salts – he was deliberately poisoned.
 2. Dr Michael, of East Care Medical Centre, Pakenham, caused delay with 3 colonoscopies – 2 were unnecessary, causing my father's condition to become hopeless. He fails to detect the mercury poisoning.
 3. Dr Michael perverts the course of Justice by advising State Coroner there was no evidence of mercury, when he could not say this because he did not test for it. The test is not performed.
 4. Defendant's mother has mercury poisoning and is ill suffering dementia in a nursing home at age 74. Mercury causes dementia and strokes. This should not be.
 5. Defendant had mercury poisoning [proven by medical tests] causing him to spent tens of thousands of dollars on medical treatment.
 6. Mail was robbed from the defendant, his father and mother and estates.
 7. The Defendant's mother was robbed of personal property and valuables \$2mil.
 8. The Defendant suffered death threats, was threatened with a steel pipe.
 9. The Defendant has been maligned, has had his relationship with his family permanently damaged because of actions taken by his sisters, been abused by locals,
10. Police would not investigate. Defendant's complaints and crimes against him get the cover up.
 11. Australia Post accepts redirection order without recipient's authority or agreement or knowledge. Interfering with someone else's mail is a crime.
 12. Australia Post exercise malice towards the Defendant and deliberately withhold evidence of mail redirections from him, the Post Master lies under oath that he does not know what happened to the mail, the Investigator for Australia Post lie under oath that he could not see that anything was wrong and they allow the mail to continue to be redirected after complaints were made.
 13. The defendant gets charged with threatening and stalking Post Master because of an effort to fix a problem.
 14. The police organised 15 witness statements against him, NO witness statements for him or addressing the crimes he, his mother and father have suffered.
 15. No investigation of the cover-up by Australia Post.
 16. His trial by Jury in County Court is aborted. Judge refused him his opportunity to prove his circumstances and defend himself in court and orders he gets a psychiatric examination.
 17. All these facts can be fully backed by other people living locally in the area surrounding my parents, by other doctors and by medical reports and records kept. The Judge has medical reports etc.

I, the Defendant, went to Victoria to help my parents but had to watch my father die; I tried to support my ill mother through her grief; I saw my life beginning to fade as my immune system began to fail, as part of my mouth rotted and I lost 4 teeth, as I began to pass black tar like stools. The smell was unbearable. There was always blood on the toilet paper. The stomach pains and bowel pains at times were excruciating. I worried and sought the cause and had an endoscopy and was diagnosed with H pylori and prescribed antibiotics - the problem did not go away. Over time things improved and then they would get worse again. I suffered bouts of diarrhoea followed by body pain. I made myself exercise, as I believed this would help. My mother had

similar problems but hers were more severe. She became very frail and had several strokes.

There was little hope as my father had suffered the same symptoms for at least a year. He had seen Doctors and had three colonoscopies. There had been blood in his faeces, but there was no cure for him so there was low expectation of me finding a cure also. My father's immune system failed him and his stomach filled with cancer and he died.

My mother and I went for treatment at Your Health Camberwell and had 14 EDTA Chelations plus medications for poor blood circulation, pins and needles in hands and feet, heart arrhythmia etc At times there was some improvements,

then one day My mother could no longer walk to the front gate again.

All the time, unknown to me, we were both being poisoned with mercury. Eventually my 6th sense told me that there was something wrong with Victoria and I moved with my mother to Queensland. She had symptoms like multiple sclerosis. I took her to a hospital and asked them to fix her. She got worse. They did not give her magnesium and zinc that the research the defendant did showed would help.

The way mercury works is it is a 2++ metal ion very much like zinc, copper, magnesium, chromium and the other essential heavy metals in our body. It is chemically stronger so drives them out and takes their place. These good metals are involved in many enzyme reactions and enzymes support the protein machinery of the body. Result; protein metabolism is totally messed up, muscles can no longer work properly, they get painfully cramped and exhaust quickly, hair falls out, the immune system weakens and fungal and bacterial infections invade. The gut wall is particularly hard hit and bleeds and cannot properly repair itself - with blood discharges etc..... It is a very terrifying and cruel "disease" I thought my mother, father and I had this "disease" and life was beginning to look very short indeed. Mercury salts also cause inflammation and inflammation can cause cancer. Mercury deaths are attributed to death by natural causes like cancer, heart attack, stroke, kidney failure, liver failure, dementia, etc.

There were regular visits for "no reason" from Police, the mail was going missing, occasional abusive calls from locals abusing me as doing the wrong thing by my mother. I had death threats including being threatened with a 4foot steel pipe held to my head. My mother was robbed by a daughter, she was abused, an attempt was made to sell my parents' farm. The daughter thought she was executor and had control so could take the money.

I have watched my mother get sicker and sicker till now she is in a nursing home losing her mind. The adult Guardian now has control and will not continue her mercury treatment.

My sister had a plan and she has implemented that plan most ruthlessly and Police and Australia post have protected her and supported her in her plan. That plan was simple, move in and live with her parents and win their confidence. Have them

appoint her executor in their will. Poison then with mercury a little at a time such that it will not be noticed and they will die from natural causes. Then exercise control, sell up their assets and take them all.

My father pleaded with me to come and help and this messed up her plans. So she made new plans that included poisoning me, maligning me to the locals, Police and postmaster, taking my mail and setting me up with stories to make me angry with the Postmaster. The Police were very keen to charge me with threatening the Postmaster and stalking him, with me in jail her problems would be solved and she could again take charge and take everything.

My sister tried to become administrator and recruited her two sisters to help by making an application to VCAT Guardianship List. Her invented stories were so persuasive that my mother needed 5 medical reports showing she was competent to avoid losing control of her businesses. The Police have done nothing to help my mother, my dead father or me get justice. In fact the Police took all our computers and caused my mother considerable stress from the loss of the computer as she could no longer do the GST.

I was to get a trial by jury in the County Court, but because I had set out, as part of my defence, to prove my father was murdered, my mother and I were poisoned, my mother was robbed and we were harassed and under considerable stress at the time I was accused of threatening and stalking the Postmaster, the Judge refused to give me my trial and ordered me to see a psychiatrist. **IMPORTANTLY, HE HAS NO MEDICAL EVIDENCE TO MAKE SUCH AN ORDER.** I do not trust the Victorian legal system. It is not a system to dispense justice.

Good riddens to government ministers who cannot deliver justice and a remedy for victims of crimes.

Call Victoria Police and tell them you were poisoned and they will treat you like a nutter.
